GENERAL RULES & REGULATIONS

1. Entry Forms, which may be copied, are available from the Secretary, or from the Show Website.
2. Entry Forms can be submitted to the Show Secretary, PO Box 10, Hughenden Qld 4821, or by Email: secretary@hughendenshow.com.au. Fax: 4741 1329. All nominations must be in writing and accompanied by full payment of nomination fee to secure nomination. No verbal nominations will be accepted.
3. Nominations must be received no later than 5pm on 26th May 2017. No late nominations will be accepted. A maximum of 10 Nominations will be accepted.
4. Competitors are to prepare a stew of choice (4 - 5 Litres) and Damper to feed minimum of 10 people. Meat will be cut into not more than 2cm cubes. Stew may be cooked with bones, however, they must be removed before presentation for judging.
5. All ingredients and cooking equipment is to be supplied by competitor.
6. All ingredients are to be prepared onsite at allotted stations – raw, whole ingredients, For Example whole potatoes, ¼ pumpkin (seeds and skin still attached), tinned tomatoes, curry powder, salt, pepper, tomato sauce, barbeque sauce, Worcestershire sauce, dehydrated peas, lentils etc. Ingredients will be presented to stewards before cooking commences. (If in doubt ask prior to event).
7. No pre-packaged mixes are allowed, e.g. no bottled spaghetti mix, soup mixes, strogonoff flavouring or items of the like.
8. Herbs can be either fresh or bottled there are to be no herb blends.
9. Competitors will present to their station between 8am – 9am.
10. Event to commence at 9am, at which time all ingredients should have been viewed by steward.
11. Stew is to be supplied to stewards ready for judging at 6.30pm in stainless steel bowls supplied
12. All timber will be supplied. Competitors are not to supply any timber.
13. Each competitor will be permitted to have 1 support person only.
14. Anyone entering and their support person entering this competition does so entirely at their own risk. Everyone connected therewith shall have no liability whatsoever for any injury to person, or loss of or damage to property howsoever caused.
