GENERAL CONDITIONS OF CONTRACT (TRADE SPACE) – PLEASE READ THE FOLLOWING CONDITIONS, COMPLETE AND SIGN THE APPLICATION FORM, THEN RETURN WITH YOUR DEPOSIT TO:- THE SECRETARY, HUGHENDEN SHOW SOCIETY P. FAILURE TO COMPLY WITH THE UNDERMENTIONED CLAUSE WILL RESULT IN CANCELLATION OF SPACE

1. Space rental charges will be paid on or before 12 Noon, Saturday 1st June, 2019 otherwise allotted space may be reallocated.
2. The allocated space is to be used only and solely for the purpose specified.
3. Gambling, disposal of any article by lot or chance, and sale of Art Union Tickets is strictly **PROHIBITED** without permission from the Show Committee.
4. No selling, canvassing, hawking or distribution of printed or other matters will be permitted outside the area contracted for, unless prearranged with committee.
5. The lessee and/or Employees are to conduct themselves in an orderly and respectful manner while they are on the Showgrounds.
6. The Secretary or Executive Committee Members of the Society shall have the power to enter upon the area described and remove any article, sign, picture or printed matter in which his/her opinion may be a cause of offence to the Public or Officials of the Society.
7. The display of approved advertising signs of any description is restricted to the area occupied by the Space Holder.
8. Trade Vehicles, vehicles conveying supplies and vehicles owned by or used by Space Holders are not permitted to remain inside the grounds after they have finished unloading display or exhibit material.
9. Trade pavilion opening times will be Friday and Saturday 8am to 9pm. Unless by prior arrangement with Show Committee.
10. Under no circumstances shall a space holder excavate, dig or place pegs in his/her area without first obtaining authority from the Ground Steward.
11. The Society undertakes to rent the space in its present position. All subsequent plumbing, carpentering and electrical requirements will be the responsibility of the lessee.
12. It is agreed that not under any circumstances will the Society be held responsible for any loss of, or damage to, the stock in trade etc., or any part thereof of any Space Holder or Exhibitor from any cause whatsoever. **This Society does not supply a Security Service.**
13. **Stall Holder Area** is to be left in a clean and tidy condition at the end of the show or upon leaving area.
14. Erection of structures of a permanent nature requires approval of the Society.
15. **BANNED ITEMS: Drug related goods (including Cocaine Kits, Bongs etc), Explicit & Hardcore T-Shirts, Fake Cigarettes, Fireworks, Crackers, Fuel type lighters (Zippo), Horns & Trumpets, Knives (incl. pen knives), Laser Pointers, Metal & Wooden Martial Art Nunchakus, Playing Cards (nude or lurid), Pressure Pack Snow, Silly String, Stink Bombs, Bouncing Beans, Sling Shots, Shanghais and Bomb Bags. Toy Guns are acceptable, however the following are not:- Ball Bearing Guns, Eight Shot Caps, Pellet Guns, Pop Downs (throw downs), Potato Guns, Replica Guns (bullet type), Roll Caps, Strip Caps, Water Pistols over 150mm (6"). Samurai Swords, English swords, & Fencing Swords are to be sold in sealed packages by licensed traders ONLY.**
16. Ground Steward's decision on allocation of ground space is final. No argument will be entered into.
17. A **DEPOSIT OF 50%** of total charges is to be returned with application. Deposit will be forfeited if cancellation is not made prior to the week of the show.
18. **CAMPING within the Showgrounds will only be permitted from Wednesday, 29/05/19, to Monday 03/06/19** Camping will only be permitted in allocated camping area. A Permit will be issued upon payment of site fee, this must be displayed to Ground Steward upon request. Camping prior to 29/05/19 will be available at the Caravan Parks within Hughenden. (Allen Terry Caravan Park Ph 47411190 or Hughenden Driveway, Ph 47411540) or by contacting Flinders Shire Council (Ph 47412900).
19. **NO DOGS ALLOWED IN THE TRADES PAVILION. ALL DOGS MUST REMAIN ON A LEASH AND MUST NOT BE TIED TO, NEXT TO OR NEAR THE RING ARENA FENCE.**
