FAILURE TO COMPLY WITH THE UNDERMENTIONED CLAUSE WILL RESULT IN CANCELLATION OF SPACE.

- 1. Space rental charges will be paid on or before 12 Noon, Saturday 3rd June, 2017 otherwise allotted space may be reallocated.
- 2. The allocated space is to be used only and solely for the purpose specified.
- 3. Gambling, disposal of any article by lot or chance, and sale of Art Union Tickets is strictly **PROHIBITED** without permission from the Show Committee.
- 4. No selling, canvassing, hawking or distribution of printed or other matters will be permitted outside the area contracted for, unless prearranged with committee.
- 5. The lessee and/or Employees are to conduct themselves in an orderly and respectful manner while they are on the Showgrounds.
- 6. The Secretary or Executive Committee Members of the Society shall have the power to enter upon the area described and remove any article, sign, picture or printed matter in which his/her opinion may be a cause of offence to the Public or Officials of the Society.
- 7. The display of approved advertising signs of any description is restricted to the area occupied by the Space Holder
- 8. Trade Vehicles, vehicles conveying supplies and vehicles owned by or used by Space Holders are not permitted to remain inside the grounds after they have finished unloading display or exhibit material.
- 9. Trade pavilion opening times will be Friday 8am to 8pm and Saturday 8am to 9pm and Sunday 8am to 12midday. Unless by prior arrangement with Show Committee.
- 10. Under no circumstances shall a space holder excavate, dig or place pegs in his/her area without first obtaining authority from the Ground Steward.
- 11. The Society undertakes to rent the space in its present position. All subsequent plumbing, carpentering and electrical requirements will be the responsibility of the lessee.
- 12. It is agreed that not under any circumstances will the Society be held responsible for any loss of, or damage to, the stock in trade etc., or any part thereof of any Space Holder or Exhibitor from any cause whatsoever. **This Society does not supply a Security Service.**
- 13. **Stall Holder Area** is to be left in a clean and tidy condition at the end of the show or upon leaving area.
- 14. Erection of structures of a permanent nature requires approval of the Society.
- 15.
